

**“METROPOLIS AT METROTOWN TASTY TREATS INSTAGRAM”
ONLINE CONTEST
(The “Contest”) RULES AND REGULATIONS**

NO PURCHASE NECESSARY. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO COMPLETE YOUR ENTRY YOU MUST READ AND AGREE TO THE FOLLOWING TERMS. PARTICIPATION IN THIS CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE CONTEST RULES. ALL DOLLAR AMOUNTS ARE IN CANADIAN FUNDS (\$CDN) UNLESS OTHERWISE NOTED.

(1) CONTEST PERIOD (the "Contest Period"):

The contest begins Thursday, August 10th, 2017 at 10:00am (PST) and ends at 11:59pm (PST) on Sunday, August 20th, 2017 (the "Contest Closing Date").

(2) HOW TO ENTER No purchase necessary.

Customers can upload and share a photo or video on Instagram from their Metropolis at Metrotown Tasty Treats experience and must use #METTREATS and @MetropolisatMet in order to participate in the Contest. Instagram only. Contestants may enter daily for a chance to win the “Grand Prize” (One (1) \$1,000 Metropolis at Metrotown shopping spree).

STEP 1: Go to Grand Court and visit the Metropolis Tasty Treats exhibit.

STEP 2: Take photo or video at the exhibit.

STEP 3: On Instagram share the photo or video using hashtag #METTREATS and @MetropolisatMet. Account settings to share photo must be set to Public and not Private.

STEP 4: Photos and videos may then be re-shared by Metropolis at Metrotown on social media.

(3) PRIZES:

There will be one (1) Grand Prize awarded.

One (1) Grand Prize of a Metropolis at Metrotown Shopping Spree
(value: \$1,000 – as two \$500 Metropolis at Metrotown gift cards).

Chances of winning depend on total amount of entries received by the contest closing date.

The following conditions apply:

All prizes must be claimed by Friday, September 22, 2017 at 5:00pm.

The prizes are non-negotiable, non-transferable and non-refundable.

Prizes must be accepted as awarded and have no cash equivalent. Substitutions of equal value may be made at discretion of contest organizers.

If for any reason, the winner is unable to accept the prize as awarded, the winner forfeits his/her right to the prize without compensation.

(4) WINNER SELECTION:

Grand Prize: The potential Grand Prize Winner (1) will be determined by random draw, selected from the pool of entries.

All winners will be notified by direct message through Instagram by or before August 25, 2017.

All entries must be submitted from a valid e-mail and public Social Media account that may be identified by reverse domain name search. Entries with private Instagram accounts will be ineligible. Potential winners may be required to provide Metropolis at Metrotown (“Metropolis”) with proof that the potential winner is the authorized account holder of the email associated with the winning entry. By entering the contest, you agree to be bound by the Contest Rules and the decisions of Metropolis, which decisions are final with respect to all matters relating the contest.

(5) ELIGIBILITY:

Employees and their immediate families of Ivanhoe Cambridge Inc. or its affiliates, Metropolis at Metrotown tenants and their employees, LukasOne Productions and their employees, advertising agency and consultants, and other sponsors and suppliers and their employees are not eligible to enter. **All winners must be 19 years of age or older. Winners under 19 years of age must be accompanied by a parent or guardian. All winners must be current residents of British Columbia, Canada. Contestants who have won a Metropolis at Metrotown prize within the last six months (Starting February 20th, 2017) are ineligible to win.**

(6) GENERAL RULES:

Entrants agree to the use of their names, addresses (city/province only) and likenesses (e.g. photo or video) for promotional purposes for this and similar promotions, for publication, and for marketing purposes by Metropolis, without further compensation or notification.

The contest is void where prohibited by law and is subject to all applicable federal, provincial and municipal laws and regulations. All incidental costs and expenses not specifically referred to herein, including (without limitation) taxes shall be the sole responsibility of the prize winner.

By entering the Contest, entrants agree to hold harmless Ivanhoe Cambridge II Inc and its affiliates, subsidiaries, agents, directors, officers and employees, LukasOne Productions, Metropolis at Metrotown (collectively the “Released Parties”) against any and all liability, damages or causes of action (however named or described) with respect to or arising out of: (i) entrant’s participation in the contest, (ii) the receipt or use of the prize awarded therein, or (iii) the administration of the Contest and the distribution of the prize awarded therein.

The Released Parties assume no responsibility for any error, omission, tampering, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or authorized access to, or alteration of entries. The Released Parties are not responsible for any problems, viruses or technical malfunction of any telephone network or lines, computer on-line systems, server providers, computer equipment, software, failure of e-mail or players on account of technical problems or traffic congestion on the internet or at any website or combination thereof, including injury or damage to participants or to any other person's computer related to or resulting from participating or downloading materials in the contest.
